



THE BEHAVIOR SCIENCE INSTITUTE

A summer science program in psychology for secondary school students . . . sponsored by Western Michigan University and the National Science Foundation.

June 30 to August 22, 1975

The purpose of the Behavior Science Institute is to offer a limited number of high school students of ability and promise the opportunity to become familiar with the applications of the methods of science to the study of the behavior of organisms.

The program, now in its thirteenth year, has proven to be of interest to students who have the ability and the desire to become scientists and the interest in applying scientific principles to the solution of social problems. The Institute promotes the intellectual development of these students by introducing them to the content, applications, and methods of the science of psychology. Six semester hours of academic credit at Western Michigan University is awarded to participants who successfully complete the program.

The Institute program extends for an eight-week period from June 30 to August 22, 1975. Instruction is conducted by the Psychology faculty at Western Michigan and by visiting scientists and technologists. The formal academic program consists of intensive courses and laboratory work.

During the first three weeks of the Institute all participants are enrolled in The Experimental Analysis of Behavior, a course devoted to basic principles of behavior and many implications of these principles. Among the topics discussed are the analysis and control of behavior through reward and punishment, neurotic and psychotic behavior, verbal behavior, the behavior of people in groups, self control, and the design of cultures.

During the fifth, sixth, and seventh weeks of the program, the following courses in specialized areas of psychology will be offered: Physiological Psychology, Child Psychology, Experimental Methodology, and Applied Behavior Analysis.

Special lectures and discussions will be conducted by eminent visiting psychologists during the fourth and eighth weeks of the program. This part of the program will provide participants an unusual opportunity to learn about current research and applications in several areas of psychology and to personally interact with outstanding scientists and practitioners.

The lecture program is supplemented by extensive laboratory work. During the first three weeks of the program all participants will be given instruction in laboratory techniques. During the last five weeks of the program participants design and conduct individual projects which may utilize either normal or retarded children or lower organisms as subjects in an area of special interest to the student.

Each summer, Institute participants come to Western Michigan from approximately twenty-five states. To be selected for participation in the program, students must have a record of above-average achievement in the biological, physical, and social sciences. In order to be eligible for admission, applicants must have completed their junior year, but not more than the first semester of the senior year, by June 1975.


