Cancellations received between February 1, 2025 and June 28, 2025, will be subject to a 10% fee. Cancellations received between June 29, 2025, and July 28, 2025, will be subject to a 25% fee. Cancellations received between July 29, 2025, and August 27, 2025, will be subject to a 50% cancellation fee. Cancellations received on or after August 28, 2025, will not be eligible for a refund, but registration may be transferred to another registrant or a future event. Cancellation is NOT subject to a cancellation fee if transferred to a future event.
